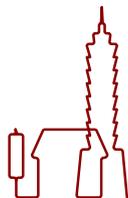

PROFIT WARNING

This announcement is made by Snack Empire Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on the Stock Exchange of Hong Kong Limited and the Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the laws of Hong Kong).

The board of directors (the “**Directors**” and the “**Board**”, respectively) of the Company wishes to inform the shareholders (the “**Shareholders**”) and potential investors of the Company that based on a preliminary assessment by the Company’s management on the unaudited consolidated management accounts of the Group and the information currently available to the Board, the Group expects to report a net loss attributable to equity holders of the Company for the year ended 31 March 2025 (the “**Year**”) of not less than S\$626,000, as compared to a net profit attributable to equity holders of the Company of approximately S\$180,000 for the year ended 31 March 2024, mainly due to (i) expenses incurred to prepare the central kitchen in Singapore to go into operation; (ii) the increase in manpower costs for both office and outlets; (iii) expenses incurred in relation to the running of a new brand; and (iv) potential impairment of certain loss-making outlets.

As the Group is still in the process of finalising the annual results of the Group for the Year, the information contained in this announcement is only a preliminary assessment by the Board based on the latest information currently available to the Board and the unaudited consolidated management accounts of the Group, which are subject to

possible adjustment(s) and review by the Company's audit committee. Shareholders and potential investors are advised to read the announcement of the Company in relation to the annual results of the Group for the Year carefully.

The annual results announcement of the Group for the Year is expected to be published on or before 30 June 2025.

Shareholders and potential investors of the Company are advised to exercise caution when dealing in the shares of the Company.
